This MoU is signed between Shree Somnath Sanskrit University, Veraval and Shree Gopalkrishna Trust, Junagadh regarding the proposal of the latter to offer financial and other supports to the University for the felicitation of the Sanskrit scholars, pundits and brilliant students. Both the parties are agreed on the followings:

- 1) It is proposed that the scholars of Sanskrit, pundits of Sanskrit, eminent professors of Sanskrit, great Shastris of Sanskrit Pathshala, men of letters and poets of Sanskrit and the eminent research scholars in Sanskrit will be honoured with the state level awards.
- 2) The following committee to select a scholar for the award is formed by agreement.
  - i. Honourable Vice Chancellor, Sanskrit University will be the head of the committee
  - ii. One of the deans nominated by the Honourable Vice Chancellor
  - iii. An eminent professor of Sanskrit nominated by the Honourable Vice Chancellor, Sanskrit University
  - iv. Honourable Registrar
  - v. One representative from the Trust

The above committee will consist of five members. In case of any disagreement the decision of the Honourable Vice Chancellor, Sanskrit University will be considered as the final decision.

- 3) The certificate of appreciation will have the following inscription.

**Shrimati Saraswati Jayantilal Hirjibhai Bhatt Award** offered by Shree Somnath Sanskrit University, Veraval.

Sponsored by **Shrimati Maniben Hirji Jadavji Bhatt and Shrimati Saraswati Jayantilal Hirjibhai Bhatt Smarak Shree Gopalkrishna Trust, Junagadh**. This certificate can be drafted in Gujarati/Hindi/English but it will be appropriate to draft it in Sanskrit. The draft will be prepared by the Sanskrit University and the expenses of the printing and a shawl will be borne by the Trust. It is proposed that the University will carry out the responsibility to maintain the consistency in it. The certificate will be signed by the Honourable Vice Chancellor, Sanskrit University and the president of the Trust.

- 4) The meeting of the committee for the selection of a Sanskrit scholar will meet once in a year, and the members will be informed about the scheduled meeting before two weeks. The expenditure for the same will have to be made within the limit of Rs.14000/- (fourteen thousands only). This expenditure will be borne by the Trust and the University will have to provide the Trust with the details of this expenditure.
- 5) The award will include the following things.
  - I. Rs. 11000/- cash prize
  - II. A shawl
  - III. A certificate

This award will be distributed by the Honourable Chancellor at the time of convocation or by any prominent personality on any relevant ceremony or function.

- 6) The students who get the first position in the programs Shastri (Vyakaran) and Acharya (Vyakaran) will be felicitated by the followings:
- A medal and a certificate will be offered to the students who stand first in Acharya (Vyakaran).
  - A medal and a certificate will be offered to the students who stand first in Shastri (Vyakaran).

The expense of the medal should be within the limit of Rs. 10000/-. The medal should be with the label mentioning the details as per sr.no. 3. If the two or more students get equal marks, the marks in the previous degree or H.S.C. will be considered. In case of any controversy, the decision made by the Honourable Vice Chancellor will be the final decision. The expenditure regarding the medals and the certificates will be borne by the Trust. The medals will be given to the students who pass the exams of Shastri (Vyakaran) and Acharya (Vyakaran) with maximum marks. The founder of our Trust, Shree Jayantilal Bhatt had accurately translated Ashtadhyayi Vyakaran, and Dr.Kishorchandra Pathak has compiled it. This has inspired us to promote the study of Sanskrit Vyakaran.

- 7) This ceremony is to be held with the convocation function. Any scholar who gets the degree of Ph.D. in Sanskrit Vyakaran and he or she is from the Sanskrit University or any institute run by or affiliated to the Sanskrit University will be honoured by a reward of cash prize and a certificate. The founder of our Trustee has translated Panini Vyakaran accurately, and hence the Trust wish to honour two scholars every year who get their Ph.D. or its equivalent degree in Sanskrit Vyakaran. Two scholars who completed their Ph.D. during a calendar year will be awarded with cash reward and a certificate. The students who got the degree in past years cannot be considered.
- Reward of Rs.6000/- to each of the two scholars
  - A shawl to each of the two scholars.
  - A certificate as prescribed in sr.3

The amount of reward unused on account of unavailability of the scholars with Ph.D. in Vyakaran will be carried forward to the next year and can be used in that year. If there are three scholars with Ph.D. in Vyakaran in any calendar year, the University will have to inform the Trust. The Trust will bear the expense for the third scholar. In case of more than three scholars eligible to get award in any calendar year, the amount for the three cash rewards will be equally distributed among all the candidates. But a certificate and a shawl will be given to all the scholars. The expense for this will be borne by the Trust.

- 8) The University has to inform the Trust about the proposed expenditure for awards, and the Trust is bound to pay it. The intimation is to be conveyed before the ceremony of award. And the Trust will give the amount to the University.



- 10) The University will have to inform the Trust in advance so that the representatives of the Trust can be present in the ceremony.
- 11) The University need not give any expense for travelling or any kind of honourium for the meeting.
- 12) The University will have to inform the Trust if in any case the expenditure for award/prize/medal exceeds the fixed sum.
- 13) The review regarding the budget for the award/prize/medal will be made every three years in order to make necessary change in it.
- 14) An MoU is to be signed between the competent authority of the University and the President/Managing Trustee to implement the above said project.





**AMENDMENT TO THE MEMORANDUM OF UNDERSTANDING SIGNED  
BETWEEN THE SHREE SOMNATH SANSKRIT UNIVERSITY, VERAVAL,  
GUJARAT AND THE FRENCH INSTITUTE OF PONDICHERY ON 19th  
JANUARY 2015 REGARDING THE PUBLICATION OF 3 VOLUMES OF THE  
VAIYAKARANABHUSANA**

Whereas a Memorandum of Understanding was signed between the Shree Somnath Sanskrit University (hereinafter referred as SSSU) and the French Institute of Pondicherry (hereinafter referred to as IFP) for bringing out the three volumes of *Vaiyakaranabhusanam* prepared by the IFP and whereas the vol. 1 of the said book has already been published, the agreement is now being amended as follows for the volumes 2 and 3 of the book:

**Article 1: Object**

The volumes 2 and 3 of the book *Vaiyākaranabhusanam of Kaundabhaṭṭa with the commentary of Prof. Ramyatna Shukla*, edited by Prof. K.V. Ramakrishnamacharyalu, shall be undertaken as a joint collaboration between three institutions (IFP, SSSU and the EFEO). The École française d'Extrême-Orient (EFEO) is a French research institution and publication partner of the IFP for Indological publications. The press-ready copy of the two volumes will be prepared by the IFP and EFEO.

**Article II: Programme and Goals**

The IFP and EFEO will provide final material, which will include page-setting and cover design on CD-ROM. The SSSU will undertake the printing job as per the format and specimen provided by the IFP/EFEO.

The IFP/EFEO will propose to the SSSU a cover for each of the 2 volumes. This cover will have to reveal: a title in Sanskrit and its explicit translation in English; the logos of the IFP, EFEO and SSSU; the series numbers of the joint IFP/EFEO series and the series of the SSSU.

**Article III: Funding**

The IFP will continue to assure the remuneration of Prof. K.V. Ramakrishnamacharyalu till the end of 2020 by which time the 3<sup>rd</sup> volume will be ready for publication. The 2<sup>nd</sup> volume will be ready by mid 2018.

The IFP and EFEO will bear the expense of page-setting and cover design of the volumes 2 and 3.

The SSSU will bear the expenditure of printing of the volumes 2 and 3. The total number of copies per volume to be brought out will be 600.

#### Article IV: Partners

The Vice-Chancellor, SSSU and Directors, IFP and EFEO will be the Project Coordinators.

#### Article V: Ownership

The volumes 2 and 3 will be under the joint copyright of the IFP, the EFEO and the SSSU. The publications shall carry the name of the IFP, EFEO and SSSU together in all title pages. The SSSU will provide 150 copies of each volume to the IFP and 150 copies of each volume to the EFEO (including complimentary copies given to the author and for review) while the remaining 300 copies will be kept by the SSSU. All three institutions will be authorized to sell their copies directly or through their distribution networks and to keep the profits from their sales.

#### Article VI: Amendments

The parties, at any time, may amend this MOU through written consent of all three.

#### Article VII: Duration

This addendum will come into effect on the date of its signature and will remain valid until all volumes of the *Vaiyakaranabhusanam* are published. Operating of the MOU shall be subject to rules and regulations, which are in force, in India.

#### Article VIII: Dispute Redressal

Disputes, if any, which arise in execution during the period of this MOU, would be resolved mutually by the Directors of the IFP and EFEO and the Vice-Chancellor of the SSSU or through a mutually agreed arbitrator.

## Memorandum of Understanding

### Article 1

The South Asia Institute of Ruprecht-Karls-Universität Heidelberg and Shree Somnath Sanskrit University agree to cooperate in the following fields:

- Academic exchange in the areas of cultural and religious studies, Sanskrit and other languages of South Asia,
- Access to library facilities and manuscript resources through cooperation between the Central Library, SSSU and the Library of Heidelberg University,
- Exchange of researchers, teaching staff and students,
- Conducting joint research projects,
- Organisation of international colloquia,
- Regular exchange of documentary publications and teaching materials.

### Article 2

A project may only be taken up once its funding has been secured. No financial obligations result from this agreement for either of the two parties unless mutual consent has been given.

### Article 3

The details of exchange of students, researchers and teaching staff shall be determined by both the parties on a project-by-project basis. Both parties declare their willingness to give their guests from the partner university every possible support during their stay.

### Article 4

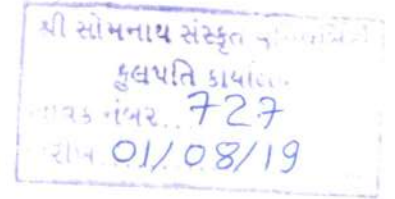

## INFLIBNET Centre

### Memorandum of Understanding (MoU) for Shodhganga/Shodhgangotri

(A Repository of Theses and Dissertations submitted to the Universities in India)

This Memorandum of Understanding (MoU) is made and entered into on 22 (Day) 07 (Month) 2019 (Year) between the INFLIBNET Centre, an IUC of University Grants Commission located at Gandhinagar, hereinafter referred to as "INFLIBNET" and Shree Somnath Sanskrit (University / Deemed University / Inter-University Centre), here in after referred to as the 'University'.

WHEREAS, INFLIBNET Centre, an Inter-university Centre of the University Grants Commission, as its mandate, promotes open access to scholarly content generated in universities. The Centre has computers, network, software infrastructure and technical know-how required for hosting electronic versions of theses and dissertations in open access with interface to search, retrieve and access these content.

WHEREAS Shree Somnath Sanskrit (University / Deemed University / Inter University Centre) has agreed to take part in the process of digitisation of old theses and dissertations (not available in computerized machine-readable format) and building-up of digital repository and to promote, share and host its ETD in 'Shodhganga: A reservoir of Indian theses submitted to the Universities in India' and other universities in open access. 'Shodhganga' is a name coined by INFLIBNET Centre for referring to the repository of Indian Electronic Theses and Dissertations. The word "Shodh" originates from Sanskrit and stands for research and discovery. The 'Ganga' is the holiest, longest and largest river in Indian subcontinent which has held heart of its people captive and drawn millions of people to its banks since the dawn of history. The Ganga is the symbol of India's age-long culture and civilization, ever changing, ever flowing, ever loved and revered by its people. "Shodhganga", a repository of theses and dissertations submitted to Indian universities, is expected to keep growing to a formidable size as more and more researchers from India submit their research works to this ever growing reservoir. Under the initiative called "ShodhGangotri", research scholars / research supervisors in universities are requested to deposit electronic version of approved synopsis submitted by research scholars to the universities for registering themselves for the Ph.D programme.

This Memorandum of Understanding (MoU) defines responsibilities, liabilities and commitments of the institutions involved to ensure proper system implementation, to meet the objectives pertaining to submission and access to Electronic Theses and Dissertations as envisaged by the UGC vide its Notification (Minimum Standards & Procedure for Award of M.Phil/Ph.D Degree), Regulation, 2009 dated 1st June, 2009.

NOW, THEREFORE, in consideration of the mutual agreements herein contained, INFLIBNET and the University agree to the following terms and conditions:

#### I. INFLIBNET Centre

1. Provide access to ETD hosting server(s) at the INFLIBNET Centre 'Shodhganga'/'Shodhgangotri' to the University with accompanied software interface enabling University / its student to create metadata and upload their theses and dissertations in ETD repositories designed for this purpose. The INFLIBNET will take the responsibility of keeping the data intact and usable, keep back-up of the data so as to avoid its loss. The INFLIBNET will deploy

tools and techniques of digital preservation to ensure continuing access to scholarly content in digital formats and to protect them from media failure, physical loss and obsolescence.

2. Recommend to the UGC to extend financial assistance to the Universities under Sections 12(B) and 2(f) of UGC Act for digitization of theses and dissertations not available in computerized machine-readable format and / or for procurement and installation of a suitable computer system / infrastructure for creation of ETDs.
3. Provide configuration of system, specifications and technical guidance to the University for procurement of computer hardware and related systems for setting-up of ETDs.
4. Provide guidelines, technical standards and specifications for digitization of Ph.D. theses submitted to the university in past and for theses not available in computerized machine-readable format.
5. Impart training to at least one person from the university (from library field and / or from computer field) in creation, updation and computerized operation of digital repositories of ETDs especially on 'Shodhganga'.
6. Extend access to an anti-plagiarism software or provide services to evaluate theses for possible plagiarism and submit a report to the concerned university.
7. The INFLIBNET may refuse to host any material deemed by the INFLIBNET to be controversial in nature or is in violation of copyright act.
8. This right of refusal will not relieve the University / Ph.D. scholar of liability, both to INFLIBNET and to the public, for matter contained in the theses that may be libelous or actionable and to both INFLIBNET and copyright owners for copyright infringement by the Ph.D. Scholar.
9. The INFLIBNET Centre will not be responsible for i) errors, omissions, inaccuracies and quality of content or misinformation or for any damages caused to the user or any third party from the use of content provided in the theses; ii) safety and archiving of loaded content in cases of "force majeure" including natural calamities; and iii) printed version of theses.
10. INFLIBNET Centre will recommend or provide access to plagiarism software which university may use to detect plagiarism before awarding the degree.
11. The INFLIBNET Centre replicates the content of theses and dissertations on different server and other auxiliary storage media. However, the INFLIBNET Centre does not take the responsibility for the archiving or backing-up of loaded content. The universities, therefore, should also keep a back-up of their theses and dissertations.

12. INFLIBNET Centre also maintains a repository called "Shodhgangotri" for hosting the approved synopses of research topic submitted to the universities by the students for registering themselves under the doctoral programme. Research students/their supervisors are encouraged to submit approved synopses/research proposals and register their priority on a research proposal through the repository.

## II. The University

1. The University would grant non-exclusive worldwide license to the INFLIBNET Centre for hosting and distributing their theses in digital format in 'Shodhganga/' 'Shodhgangotri' or any other server designated for this purpose.
2. The University / its researcher scholars agree to host / upload a computerized machine-readable file in mutually agreed format of all theses on to the 'Shodhganga/' 'Shodhgangotri' server at the INFLIBNET.
3. The University will not hold INFLIBNET Centre responsible for any errors and omissions contained in the original theses.
4. The University commits to digitize theses and dissertations and their bibliographic records submitted to the university and provide necessary infrastructure including manpower support for operation of ETDs.
5. Commits to utilize the assistance provided by the UGC on recommendation of the INFLIBNET for implementation of ETDs including their digitization.
6. Deputes at least one person from the university (from library field or from computer field) for undergoing training on implementation of ETD organized by the INFLIBNET and ensure that the person trained by INFLIBNET on ETD is / are deployed for the same job.
7. Arranges to provide training to research scholars or users of its library and staff of colleges affiliated to University in creation of electronic version of theses and their deposition in the ETDs.
8. Ensures use of standard software and metadata schema suggested / provided by the INFLIBNET for setting-up / development / operation of its ETDs .
9. Creates bibliographic records of all theses and dissertations submitted to the university in standard bibliographic formats prescribed by the INFLIBNET Centre from time-to-time and contributes these records for inclusion in the INFLIBNET's Union Catalogue (IndCat).
10. Commits to sharing of library ETD resources / databases with the INFLIBNET Centre as well as with other universities.


11. The University would agree to host their ETDs in the digital repositories 'Shodhganga or other servers' set-up at the INFLIBNET Centre, and grant non-exclusive licence to the Centre to make electronic version of theses in full-text (theses that are born digital as well as those that are digitized using scanners / digital cameras) accessible through open access ETD.
12. The University shall not use electronic version of theses digitized using funds given by the UGC for any commercial purposes. The University shall not rent, sell or license the use of or deliver or release or otherwise part with the possession of the systems / software or the INFLIBNET ETDs databases, Shodhganga or any part thereof to any other party (individual, institution, organization, etc.)
13. The University will also commit their own funds or grants for fulfillment of the project, if the project on implementation of ETDs demands more resources and funds to complete it.
14. The University will use the plagiarism software recommended by the INFLIBNET and made accessible to test the thesis submitted by the student for plagiarism before awarding the Degree. If the university is not subscribing to such software, it will use the software from the nearest Regional Centre, if any.
15. University would encourage and ensure that Research Scholars/ Research Supervisors deposit host their approved Research Proposals/ approved synopses on the "Shodhgangotri" once Ph.D. is registered.

### III. Termination

Both, the Parties, will have rights to terminate the MoU at any time in case of breach of obligations and terms and conditions of the MoU. This MoU signed hereunder may be terminated by either party at anytime upon ninety (90) days prior written notice. Upon termination of this Agreement, the INFLIBNET / University will stop hosting their theses immediately while keeping the theses already deposited by the University in its archives for its users. The University shall stop using the INFLIBNET's ETD facilities and databases and return any software / hardware or digitized content provided by or through the INFLIBNET, back to INFLIBNET within the 3 months notice period.

**MEMORANDUM OF UNDERSTANDING (MoU)**  
**BETWEEN**  
**THE GUJARAT NATIONAL LAW UNIVERSITY, GANDHINAGAR, INDIA**  
**AND**  
**SHREE SOMNATH SANSKRIT UNIVERSITY, VERAVAL**

Gujarat National Law University (GNLU), Gandhinagar, India and Shree Somnath Sanskrit University, Veraval, Gujarat, each a "party" or "institution," wishing to establish a cooperative relationship through mutual assistance in the areas of education and research, agree as follows:

**1. SCOPE OF COLLABORATION**

- 1.1. **General Scope.** Each institution may offer to the other opportunities for activities and programs, such as teaching, research, exchange of faculty and students, and staff development that will foster a collaborative relationship.
- 1.2. **Specific Activities:** The purpose of this MoU is to develop academic and scholarly partnership in history and Sanskrit, through means of various programmes and activities and to promote mutual cooperation between the two parties to further promote their individual mandates.
  - 1.2.1. The Parties agree to co-operate in the following areas:
    - 1.2.1.1. Academic exchange programmes for students and faculty;
    - 1.2.1.2. Jointly organizing academic programmes;
    - 1.2.1.3. Collaborative research and exchange of scholar;
    - 1.2.1.4. Participation, mutual assistance, joint organization of seminars, conferences and workshops;

- 1.2.1.5. Exchange and access of academic publication materials or other information; and
- 1.2.1.6. Any other programmes to be mutually agreed upon.
- 1.2.2. While exchanging scholars and participating in seminars and conferences, the home institute shall bear for the travel and incidental expenses whereas the host institute shall make arrangements for local hospitality.
- 1.2.3. The development and implementation of specific activities based on the MOU will be separately negotiated and agreed between the parties.

## 2. RENEWAL, TERMINATION AND AMENDMENT

- 2.1. **Duration:** This MOU shall remain in force for five years from the date of the last signature. Either party may terminate this MOU by providing 60 days' advance written notice to the other party.
- 2.2. **Extension and Renewal:** The parties may extend or renew this MOU by agreement, confirmed in a written amendment signed by each party's authorized signatory.
- 2.3. **Amendments:** No amendment of the terms of this MOU will be effective unless made in writing and signed by each party's authorized signatory.

## 3. GENERAL MATTERS

- 3.1. **Notices:** The parties must give all notices under this MOU in writing through registered post or email. All communications must be sent to the addresses set forth below or to such other address designated by the parties by written notice. Notices are effective upon receipt.

**3.2. General Principles:**
